Keys



Just a reminder that you are responsible to have your keys with you at all times. Caretakers are not available to open doors and the office does not hand out keys. If you do not have your keys, you will have to hire a locksmith to open the door.

If you lose your keys or fobs, there will be a charge for all items being replaced. If you lose your fob, please come in early in the day to have it replaced. Programming the Fobs are time consuming. Please do not wait until the end of the day, as office staff are very busy.

Also remember to hand in all keys, fobs and laundry cards when you move out. If you do not return these items, you will be charged for them and the money will be taken from your damage deposit.

LEASE REMINDER FOR NOVEMBER 1, 2020 LEASE RENEWAL

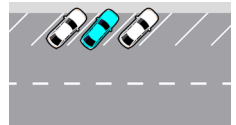


Please forward immediately to WHRC any lease renewals that were due back July 31, 2020 or rent is automatically set to Market rent.

Parking

Please remember that when parking your vehicle, you do not park it right next to the garbage bins.



There are no parking spots allocated right beside the bins on either sides. This is to ensure the city has room to move the bins when they come for garbage day pick-up.

If you have visitors with vehicles, it is your responsibility to ensure they do not park close to the bins or in other tenants parking spots.

If you park next to the bins, the city will be unable to pick up the garbage on the scheduled day and garbage collection will then have to wait until the following week.

Recycle

Please do not place recycled items into garbage bins.

All cardboard boxes must be broken down when placed into the bin.

Items you can put into recycling:

- Food and beverage containers
- Plastic containers with a recycling triangle
- Plastic packaging with a recycling triangle
- Newspapers, flyers, mail, magazines and paper
- Cardboard boxes and cartons
- Cardboard egg cartons and paper tubes

Items you cannot put in a recycling bin:

- Gift wrap
- Plastic bags and cellophane
- Plastics without a recycling triangle
- Plastics that are not a container such as laundry baskets and toys.
- Disposable coffee cups
- Aluminum foil, foil pie plates, foil food containers
- Foam-containers, cups, meat trays, egg cartons and packing materials

When items are found in recycling that do not belong there, they get sent to the landfills, sometimes with things that are recyclable. Please put the right items in the garbage and recycling to ensure your waste is recycled.
