This option should help to reduce the hassle of having to come to our corporate office to pay for rent by either cash, cheque, debit, and/or money order.

Under "Tenant Information", click on "Online payment tab", you will be prompted to an online form where you will need to provide your unit number and building address, along with your full name and email address.

WHRC OFFICE


Winnipeg Housing Rehabilitation Corporation (WHRC) will re-open the office to the public on Monday, June 8, 2020.

Office hours will continue to be as follows:

Monday – Friday from 8:30 a.m. – 4:30 p.m. closed for lunch from 12:00 p.m. – 1:00 p.m.

WHRC will continue to follow public health guidelines. Please be aware of the following if you come to the office:

Social Distancing Requirements (6 feet apart).



- Only one (1) person (or couple/family) will be allowed in the office at a time.
- Please wait in the designated area as marked on the floor and respect social distancing requirements.
- Hand sanitizer will be available in the reception area please use.
- If you have an appointment please contact the individual that you made the appointment with and let them know that you are at the office.

Programming at Sites (Tenant Resource Coordinators)

The Tenant Resource Coordinators will start planning programming for sites. The following will be required to ensure that we follow Public Health orders and keep all tenants safe.

- Participants will be informed of physical distancing, hand hygiene, and cough etiquette requirements.
- Maintain lists of participants for 21 days to ensure appropriate public health follow-up can take place if a participant be exposed to COVID-19 during these activities.
- Set-up space (e.g. chairs, tables) to allow for physical distancing.
- Group activities, limiting group sizes to no more than 25 people indoors
- Limit the amount of time of interactions and group activities.
- Practice hand hygiene hand sanitizer will be available.

Laundry Room



Winnipeg Housing would like to remind you that the laundry rooms in your buildings are shared spaces.


Therefore, we ask that you clean up after yourselves, by putting used dryer sheets and lint in the garbage.
